### Ticket prices and prize limits

Lottery tickets may not be sold by any person under 16 years of age or to any person under 16 years of age, and all tickets must be paid for before they are entered into the draw. Tickets may be sold from a kiosk, in a shop and door to door. They <u>may not</u> be sold in a street (including passages through enclosed premises such as shopping malls).

#### Tickets:

- Must identify the society
- State the price of the ticket
- > State the name and an address of a member of the society who is designated by persons acting on behalf of the society as having responsibility within the society for the promotion of the lottery, or, if there is one, the external lottery manager
- > Either states the date of the draw or enables the date of the draw to be determined
- There is no price limit on tickets but they must all cost the same, and the possible proceeds must not exceed £20,000.

It must not be possible for the purchaser of a ticket in a small society lottery to win (whether in money, money's worth or partly one and partly the other) more than £25,000.

At least 20% of the proceeds of the lottery must be applied to the purpose for which the promoting society is conducted.

The promoting society of a small society lottery must throughout the period during which the lottery is promoted be registered with a Local Authority.

A lottery may include a rollover only if each lottery, which is affected by the rollover is also a small society lottery promoted by or on behalf of the same society.

The proceeds of one lottery may not exceed £20,000. The aggregate of proceeds from lotteries promoted wholly or partly during a year may not exceed £250,000

A Return must be submitted within 3 months of any lottery
